Biofuel: A Sustainable Solution for Energy Supply in the 21st Century

Biofuel has emerged as a viable alternative to fossil fuels, addressing the growing need for sustainable energy solutions worldwide. Derived from organic sources like biomass and plant matter, biofuels offer numerous benefits, including reduced greenhouse gas emissions, enhanced energy security and economic gains. This review explores cutting-edge biofuel production technologies and their significance as a sustainable energy source. Biofuels come in various forms, such as biodiesel, bioethanol and biogas, produced through fermentation, gasification and transesterification. Each biofuel type has distinct qualities and applications. However, challenges persist, including resource competition with food production and technological inefficiencies. To overcome these obstacles, innovations and advancements are necessary. Supporting policies and legislation must be implemented to ensure sustainable biofuel production. Collaboration among scientists, policymakers and industry stakeholders is crucial for developing a sustainable biofuel sector. Biofuel technology holds great promise for meeting the 21st century's energy demands while reducing fossil fuel dependence and environmental harm. Further research and innovation are necessary to optimize production processes and fully realize biofuel's potential.

1. Introduction

Biofuel is a renewable power option that is derived from animal manure and biomass (feedstocks), which includes plant and algae. Fossil fuel depletion, rising fuel costs, increased fuel consumption, and global warming are the factors contributing to the trending research into alternative energy generation possibilities (Jayakumar et al., 2023). Also, the human-caused greenhouse gas (GHG) emissions from fossil fuel production and use, including the release of carbon dioxide (CO₂) have recently elevated the advancement of clean energy sources to a global priority. Unlike traditional energy sources (fossil fuels), it can be created quickly from biomass, which makes it a renewable energy source. Energy for transportation, heating, and power generation are all possible with biofuel (Dick, 2014).

Research on biofuels has progressed significantly since 2000. Biomass uniquely offers solid, liquid, and gaseous fuels. Wood fuels remain steady, while wood chips/pellets for energy have grown 100% and will keep rising (Praveena *et al.*, 2024).

Drop-in transportation fuels, pyrolysis bio-oil, bioethanol, and biodiesel are all considered liquid biofuels. Commercial manufacturing of bioethanol from lignocellulosic compounds has only recently begun, augmenting the 22 billion gallons produced annually, mostly from agricultural products (Bušić *et al.*, 2018). The production capacity of oil seed biodiesel has reached 5670 million gallons per year, and additional increases are contingent upon the development of new feedstock. Drop-in biofuels and bio-oil are still in the development stage and face difficulties in upgrading and cost-effective conversion (Brahma *et al.*, 2022).

Syngas and biogas are examples of gaseous biofuels. In Europe and China, the anaerobic digestion process of producing biogas from organic matter has been growing quickly. This process has the potential to replace 25% of the natural gas consumption that occurs now. On the other hand, the process of producing syngas by the incineration of wood-based biomass is limited in its application due to its ineffective cost (Guiot and Frigon, 2012).

The rationale for this review is centred on biofuels' potential to mitigate climate change, ensure energy security, and foster sustainable development through reduced emissions, energy diversification, and rural economic empowerment. Biofuels offer a low-carbon alternative to fossil fuels, mitigating greenhouse gas emissions. Diversifying energy sources reduces dependence on imported fuels, enhancing energy independence. Biofuels support rural economies, promote renewable energy, and create jobs. Recent advancements in biofuel technologies warrant updated analysis.

2. Types of Biofuels

2.1. First generation biofuels

Energy crops like sugarcane, sugar beet, and sorghum, starch-based crops like corn, wheat, and barley, or oil-based crops like rapeseed, sunflower, and canola are used to make first-generation biofuels (Dahman et al., 2019). The fermentation or chemical processes used to create these biofuels transform the oils, sugars, and starches in the biomass into liquid fuels (Cavelius et al., 2023). First-generation biofuels that are most widely used are bioethanol and biodiesel (Hirani et al., 2018). Since different feedstocks can be used to manufacture these biofuels, production can be flexible based on local conditions and resource availability (Martin, 2010). Despite availability and the fact that they have been in use for a while (Nagler and Gerace, 2020) the manufacture of biofuel from food crops can raise issues with food security and raise the question of whether food should be used for fuel or food (Naqvi and Yan, 2015). Also, it has been shown that the potential for first-generation biofuels to reduce overall emissions may be limited since they may emit more greenhouse gases than other generation biofuels (Moodley, 2021). However, first-generation biofuels remain a crucial component of the alternative energy sector.

2.1.1. Bioethanol

The most well-known biofuel is bioethanol, which is generally obtained by fermenting crops like sugarcane, maize, and wheat (Mohapatra *et al.*, 2019). And without requiring engine adjustments, it can be primarily converted to conventional fuel in amounts up to 5% to raise its octane and lower pollutants that cause pollution, such as carbon monoxide (Ibeto *et al.*, 2011). In addition to being far less harmful than fossil fuels, bioethanol is also biodegradable, making it a more environmentally responsible choice (Balat *et al.*, 2008).

2.1.2. Biodiesel

Long-chain fatty acid methyl esters are the main component of biodiesel, a type of fuel oil made from plants or animals. It is usually generated by lipids that react chemically, like lard, soybean oil, or any other vegetable oil, with alcohol and microalgae lipid through the process of transesterification, and it results in the production of methyl, ethyl, or propyl ester (Malabadi *et al.*, 2023). Non-edible feedstocks have emerged as a sustainable biofuel source, leveraging waste land and yielding comparable or

higher outputs than edible counterparts (Devarajan et al., 2022). The energy equilibrium of soybean biodiesel is positive, which indicates that the fuel's energy content exceeds the energy required to create it (Fore et al., 2011). Compared to diesel made from petroleum, biodiesel is less harmful to the environment, safe, and biodegradable. It can be used in its natural state, B100 or blended with petroleum-based diesel. Blends such as B5 and B20, or B2 (2% biodiesel), are widely utilized. Othman et al. (2017) observed that most manufacturers are satisfied with mixtures up to B5. A few accept mixes up to B20. Biodiesel has less carbon and more oxygen and hydrogen than conventional fuel. This quality lowers the amount of unburned carbon particles and the rate at which biodiesel burns (Torkashvand et al., 2022).

2.1.3. Biogas

Biogas is generated from waste products such as compost, agricultural litter, plant matter, waste water and food scraps. Anaerobic microbes, also known as methanogens, produce biogas by decomposing biological waste in an oxygen-free atmosphere (Calero et al., 2023). Methane (CH₄) and carbon dioxide (CO₂) make up the majority of the gas composition, with trace amounts of moisture, siloxanes, and hydrogen sulfide (H₂S) possible (Malunga, 2018). The generation of biogas contributes to the decrease in methane emissions that fuel global warming. Additionally, it can lessen the need for waste dumps, which emit the hazardous greenhouse gas methane (Harris, 2014). Biogas's composition can be difficult to control because of its variable methane-to-carbon dioxide ratio. Although the ratio can vary from 45% to 75% methane and 55% to 95% carbon dioxide, the most typical ratio is 60% CH₄ (methane) and 40% CO₂ (Al-Timimi and Yaakob, 2022).

2.2. Second generation biofuels

These biofuels are produced using lignocellulosic biomass a structural substance made primarily of lignin, hemicellulose, and cellulose, which makes up a large portion of plant mass. In order for cellulose to ferment into alcohol, lignin and cellulose in plants separated. This includes both non-food are agricultural residues (like hulls of rice or corn stalks) and non-edible plant biomass (like grasses or trees grown specifically for energy) (Naik et al., 2010). Cellulosic ethanol is the primary form of secondgeneration biofuel now in use or being developed. It is made by fermenting carbohydrates (Kowalski et al., 2022). The methods for producing them are less refined and more complicated than those for firstgeneration biofuels (Nagler and Gerace, 2020). The development of biofuels of the second generation is less harmful to the environment than that of the first since it may be used as an efficient waste management tool, diversify sources of energy and reduce dependency on carbon-based fuels

(Kowalski *et al.*, 2022). In line with life-cycle assessments, second-generation biofuels will result in "net energy increases," circumventing one more major drawback of first-generation biofuels (Kumar *et al.*, 2022).

2.2.1. Cellulosic ethanol

A variety of feedstocks, including maize residue, switchgrass, miscanthus, sugarcane bagasse, and other grasses or woody crops, can be used to create cellulosic ethanol, a second-generation biofuel. Since it is capable of being produced from unconsumable plant components and doesn't disrupt the food chain, this form of ethanol is thought to be better for the environment than first-generation biofuels (Kumar *et al.*, 2022). However, the conversion rate, or the quantity of raw materials required to make the same volume of ethanol, is one of the difficulties in producing cellulosic ethanol (Ziolkowska, 2020).

Biochemical and thermochemical processes are the two main techniques used in the synthesis of cellulosic ethanol. The biochemical process includes a preliminary step that involves releasing the hemicellulose carbohydrates. Cellulose and hemicellulose are hydrolyzed by enzymes to yield simple sugars. Sugars are subjected to fermentation to generate water and ethanol, which are further separated by distillation (Guo *et al.*, 2022).

The thermochemical process involves pretreatment to induce swelling of hemicellulose and cellulose. Hemicellulose and cellulose are then hydrolyzed chemically to produce simple sugars followed by fermentation of the sugars into carbon dioxide and ethanol. Then a final distillation process to extract ethanol from water (Lynd *et al.*, 2017).

2.2.2. Algal biofuel

Produced from algae, algal biofuels represent a viable renewable energy source (Gajraj et al., 2018). Due to their quick biomass production and relatively high oil content in the form of triacylglycerol, microalgae have long been considered promising sources for biofuel generation (Ganesan et al., 2020). When compared to conventional crops, microalgae develop extremely quickly. Algal mass production can be carried out on non-arable fields using sewage and non-potable saline water (Adetunji et al., 2023). Growing the algae, collecting the biomass, and extracting the oil, which is subsequently converted into biodiesel are the stages involved in the manufacturing of algal biofuels (Pragya et al., 2013). Currently, the cost of producing algae-based biodiesel prevents its commercialization, though, and there are issues with selecting high lipid-containing algae strains as well as high infrastructure, operation, and maintenance expenses (Saad et al., 2019).

2.2.3. Biohydrogen

A promising sustainable energy source. Numerous biological processes can be used to create biohydrogen (Kumar Gupta et al., 2013). The creation of biohydrogen can be achieved by three main technologies; anaerobic dark fermentation, and dark fermentation combined, light and photosynthetic (Ahmed et al., 2021). The aforementioned techniques use different feedstocks. The production of biohydrogen is confronted with obstacles for instance, poor output and expensive manufacture; nonetheless, research is progressing enhance its efficiency by adjustments in to processes, physiological manipulations, and genetic engineering (Putatunda et al., 2022).

2.3. Third generation biofuels

These are more sophisticated and made from microalgae or algae (Müller et al., 2023). Algalbased biofuel output is approximately ten times higher than that of biofuels made from secondgeneration algae, making them a more effective source of energy (Neto et al., 2019). Since algae are not consumed by humans or animals, they don't endanger the food chain (Behera et al., 2015). Because algae can absorb carbon dioxide from the atmosphere, they aid in lowering the release of greenhouse gases (Bajpai, 2019). However, due to significant energy and infrastructural the requirements, the generation of biofuels derived from algae is more costly than that of conventional fossil fuels (Lee and Lavoie, 2013). It is also difficult and costly to control the environment for the best growth of algae (Alaswad et al., 2015).

2.3.1. Biobutanol

The 4-carbon alcohol biobutanol is made from an array of feedstocks, such as grain of maize and various biomasses (Liu et al., 2022). Because of its higher energy content and reduced water absorption, it's thought to be a more effective fuel for energy than ethanol (Guo et al., 2022). Better blendina ability. less corrosiveness. and compatibility with the current gasoline distribution infrastructure are just a few of the benefits that biobutanol has over ethanol (Radloff et al., 2016). But there are difficulties in producing it, like high production costs, time requirements, and sporulation stage (Liu et al., 2022). The production process involves; feedstock preparation and pretreatment, fermentation process, product recoverv and purification. Enhancing the fermentation stage's efficiency, modifying the raw material's pretreatment, creating new substrates, and creating more efficient preparation techniques remain the primary area of study and development for the biobutanol industry. The manipulation of microorganisms, biomass, and the substrate necessary for microbial growth has all been investigated through recombinant DNA technology (García et al., 2011).

2.3.2. BioDME

Bio-dimethyl ether, or BioDME, is a sophisticated biofuel made from biomass. It offers various benefits for the environment and the economy and suitable for usage as a renewable diesel engine fuel (Im-orb and Piroonlerkgul, 2023). It has been demonstrated that BioDME, which is made from lignocellulosic biomass, produces considerably lower greenhouse gas emissions compared to fossil fuels (Parvez et al., 2018). With better, cleaner combustion, it is potentially utilized in a range of vehicles, mainly cars, trucks, trains, and ships to replace diesel fuel (Himabindu and Ravikrishna, 2010). The process of producing BioDME from biomass is very intensive and versatile, possibly substituting a large amount of fossil fuels and lower carbon dioxide emissions (de Jong et al., 2023)

2.3.3. Synthetic Hydrocarbons

Hydrocarbon fuels known as synthetic hydrocarbons (SHCs) are made from sources of biomass through a range of biological and thermochemical methods (Konarova *et al.*, 2022). They can be used as renewable fuel in diesel engines and are regarded as advanced biofuels. Better blending ability, less corrosiveness, and compatibility with the current gasoline distribution infrastructure are a few benefits of SHCs (Willauer and Hardy, 2020).

2.4. Fourth generation biofuels

These are a relatively new idea. Their goal is to provide a means of capturing and storing CO_2 while producing sustainable energy. They are made from genetically engineered microorganisms and feedstocks, such as algae. (Mat Aron *et al.*, 2020). In comparison to earlier generations of biofuels, they are anticipated to be a lot efficient, and they may also be able to lessen harmful emissions and the consequences of global warming (Goria *et al.*, 2022).

2.4.1. Bioelectricity

The electrical currents and potentials produced by or existing within live cells, tissues, and organisms are referred to as bioelectricity. It is involved in a number of biological activities, such as nerve impulses, muscle contractions, and cell communication. Bioelectricity generation, on the other hand, is the process of using bioelectricity as a renewable energy source (Dessie and Tadesse, 2022). Biopower systems use processes including burning, bacterial decomposition, and conversion to gas or liquid fuel to turn sustainable biomass fuels into heat and electricity (Rojas-Flores *et al.*, 2021). Bioelectricity may find use in medical devices and epidermal regeneration (Martinsen and Heiskanen, 2023).

2.4.2. Solar fuels

Solar fuels are synthetic chemical fuels made from sun radiation by a variety of mechanisms, including photochemical, photobiological, and electrochemical reactions (Haussener, 2022). Because they are sustainable and renewable, they are viewed as a possible replacement for conventional fossil fuels (Styring, 2012). Potential solar fuels include ammonia and hydrazine, hydrogen, and alcohols (such methanol and ethanol) (Detz *et al.*, 2018). Solar fuels can be easily stored and transported due to their high energy density. The absence of netzero carbon emissions is a distinguishing feature of solar fuels over fossil fuels, which renders them ecologically harmless (Armaroli and Balzani, 2016).

3. **Production Methods of Biofuels**

Nature of feedstock (biomass) and its intended application determine production process that is employed. For instance, crops with high sugar or lipid content can be fermented to produce ethanol, and oilseed crops like sunflower or canola are capable of generating biofuels (Ruan *et al.*, 2019).

3.1. Sugar fermentation

In order to convert biomass into bioenergy, this is the method that is most frequently employed. Using this method, cellulosic feedstocks, sweet sorghum, corn, sugarcane and sugar beet are converted into bioethanol (Li and Khanal, 2016 and Pandey, 2011). First, the biomass is hydrolyzed by an enzyme or an acid to produce sugar, which is subsequently metabolized (fermented) by microorganisms like the veast. Saccharomyces cerevisiae to produce ethanol. The most common fermentation substrate is often 6-carbon sugars (Li and Khanal, 2016). Other microorganisms can also ferment five-carbon sugars that come from plant material, or lignocellulosic biomass (Naveed et al., 2024). The efficiency, temperature requirements, pH range, and substrate specificity of different microorganisms and fermentation processes can differ (Tropea, 2022). In contrast to feedstocks derived from sugar. feedstocks derived from starch necessitate starch hydrolysis, or the liquefaction and saccharification of starch, in order to vield fermentable sugars following milling and mashing (Rodionova et al., 2017).

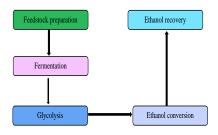


Figure 1. Sugar fermentation process. Integrated from Manmai *et al.* (2020). Illustrated by the authors.

3.2. Hydrolysis

The extraction of sugars from lignocellulosic biomass can be accomplished using a variety of techniques, including enzymatic, chemical, and physical processes. The two most effective techniques among them are enzymatic and chemical hydrolysis (Ruan et al., 2019). Utilizing concentrated mineral acids like HCl and H₂SO₄, chemical hydrolysis can be carried out. More manageable and less dangerous cellulose solvents, including ionic liquids, can also be used for it. Despite being relatively inexpensive, the acid hydrolysis approach's utilization is restricted since using powerful acids has negative environmental effects and low yields (Ho et al., 2014).

Highly specialized cellulase enzymes are often responsible for enzymatic hydrolysis, which results in the production reducing sugars, such as glucose. Enzymatic hydrolysis is typically carried out under milder circumstances than chemical hydrolysis, which uses stronger acids (Binod *et al.*, 2011).

3.3. Digestion

In order to speed up the breakdown of biomass feedstock, biomass digestion uses microorganisms. This process can take place in either anaerobic or aerobic settings. However, anaerobic digestion has a few benefits over aerobic digestion, including increased organic removal efficiency, increased organic loading rate, decreased nutrient requirement and decreased energy requirement (Okoro et al., 2017). In anaerobic digestion, biogas is produced which, depending on the water content, has a methane concentration of roughly 55-75% and a carbon dioxide level of 25%-45%. Additionally, trace gasses like hydrogen sulfide could be created (Champagne, 2008). Specialized bacteria break down complex organic compounds, such as proteins, lipids, and carbohydrates, into smaller molecules, such as soluble sugars, amino acids, and fatty acids, during the anaerobic digestion process. The general reaction is:

C₆H₁₂O₆ → 3CO₂ + 3CH₄

Steps involved include (Gould, 2015):

- i. Hydrolysis: Proteins, lipids, carbohydrates, and other big organic polymers are hydrolyzed to produce simpler molecules like fatty acids, amino acids, and simple sugars, and so on.
- ii. Acidogenesis: The process by which acidproducing bacteria and other microbes degrade organic compounds to produce an acidic environment.

- iii. Acetogenesis: Acetate-producing break down a large number of the chemicals generated during acidogenesis into acetic acid, CO₂, and H₂.
- iv. Methanogenesis: The end products of acetogenesis as well as some of the intermediate products of hydrolysis and acidogenesis are converted into methane by methanogens via two main routes.

Methanogenesis requires precise conditions to occur. Physically, it thrives at temperatures of 25-40°C, pH 6.5-8.0, pressures up to 100 atm and redox potentials of -200 to -400 mV. Chemically, it needs nutrients like CO₂, H₂ and acetate, while inhibited by O₂, NO₃- and heavy metals, tolerating freshwater to hypersaline environments. Biologically, methanogenesis involves microorganisms like Methanobacterium and Methanosarcina in anaerobic environments (Ferreira et al., 2022). Optimal conditions include temperatures of 35-40°C, pH 7.0-7.5 and redox potentials of -300 to -350 mV. Factors methanogenesis include temperature affecting fluctuations, pH shifts, inhibitor presence, nutrient limitations and microbial community composition (Ghosh and Kar, 2024). Understanding these conditions optimizes methanogenesis in biofuel production (Zakaria and Dhar, 2019).

3.4. Transesterification

Plant biofuels are made of methyl or ethyl esters of long-chain fatty acids. They are often created when alcohols (ethanol or methanol) react with mono, di, and triglycerides (TAGs) or free fatty acids (FAAs) (Barbosa et al., 2022). The process of transesterification transforms triglycerides (fats and oils) into a mixture of fatty acid methyl esters (FAME) in the presence of alcohol, methanol or ethanol and a base catalyst usually potassium hydroxide or sodium hydroxide to produce biodiesel (Baskar et al., 2019; Clifford, 2021). This reaction significantly decreases the viscosity of non-edible oil (Teo et al., 2022). Oil seed that has more than 20% oil content qualifies as an oil feedstock for the synthesis of biodiesel (Li and Khanal, 2016).

3.5. Thermochemical conversion

Thermochemical conversion routes break connections between nearby hydrogen, oxygen, and carbon molecules to release the chemical energy that was generated in the course of photosynthesis. Examples of thermochemical transformation include gasification, liquefaction, pyrolysis, and combustion (Ram and Mondal, 2022). The amount of O_2 changes the process during every step of the thermochemical conversion of biomass. Combustion is the thermochemical process that requires an excess of oxygen, while pyrolysis is the process that does not require oxygen (Ong *et al.*, 2019).

3.5.1. Gasification

Gasification transforms solid biomass into a combination of gases called synthesis gas (syngas), that consists of carbon dioxide (CO₂), hydrogen (H₂), and carbon monoxide (CO) by employing heat and a gasifying agent. After that, the syngas can be utilized to make biofuels. By using chemical processes like Fischer-Tropsch synthesis, synthesis gases can create fuel and other compounds (Brown, 2019). Reactor design, temperature, gasification agent (steam, oxygen, or air), and feedstock characteristics are some of the variables that affect the complicated process of gasification (Ortiz, 2022). Gasification reactions include:

- i. Partial oxidation: The biomass is partially oxidized when a specific volume of air or oxygen is added to the chamber. In addition to producing heat, this supplies oxygen for the gasification reactions (Lin and Wu, 2019).
- ii. Reduction: Reduction reactions occur when the oxygen in the chamber interacts with the emitted volatile chemicals and char. Tar and other complex hydrocarbons are broken down by these processes, releasing carbon monoxide (CO) and hydrogen (H₂) (Singh *et al.*, 2022).
- iii. Water-gas shift reaction: In addition to carbon dioxide (CO₂), the syngas generated in the preceding phase also contains H₂ and CO. Steam is added to the water-gas shift process so that it can react with the carbon monoxide (CO) and produce more hydrogen (H₂) and carbon dioxide (CO₂). The syngas's composition can be adjusted with the aid of this shift reaction (Tanger *et al.*, 2013).

3.5.2. Hydrothermal liquefaction (HTL)

This process turns biomass into biofuels in the presence of water while operating at high temperatures (200-400°C) and pressures (10-25 MPa) (Zhang and Chen, 2018). Alkali salts like potassium and sodium carbonate can work as a catalyst to break down macromolecules like cellulose and hemicellulose into tiny fragments. The thick heavy oil that is produced during the liquefaction process can occasionally be difficult to handle. Propanol, methyl ethyl ketone, butanol, acetone, ethyl acetate, and other organic solvents are introduced to the reaction system to loosen it (Ruan et al., 2019). Volatile organic acids, alcohols, aldehydes, ethers, esters, ketones, and nonvolatile components are typically found in high concentrations in biofuels that are produced during the liquefaction process. Components might be enhanced chemically to create an organic distillate product that is abundant in valuable compounds and hydrocarbons (Yu *et al.*, 2023).

3.5.3. Pyrolysis

This method uses heat in the absence of oxygen to turn biomass into biofuels (Su *et al.*, 2022). Traditional electrical pyrolysis is categorized into three groups depending on the operating features include residence time, pyrolysis temperature, and heating rate. These three types of pyrolysis are flash, rapid, and slow (Ruan *et al.*, 2019 Fast pyrolysis, which involves rapidly heating biomass to a high temperature in the absence of oxygen, produces, depending on the feedstock used, 60%– 75% oily products (oil and other liquids), 15%–25% solids (largely charcoal), and 10%–20% gaseous phase. (Jahirul *et al.*, 2012). In pyrolysis, the biomass feedstock reacts as follows overall:



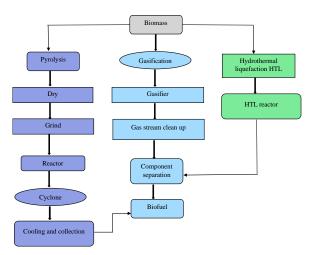


Figure 2. Thermochemical conversion process including pyrolysis, gasification and hydrothermal liquefaction. Integrated from Ram and Mondal (2022). Illustrated by the authors.

3.6. Electrofuel production

Utilizing microorganisms to produce liquid transportation fuels devoid of photosynthesis is known as electrofuel production. These microbes convert carbon dioxide (CO_2) into liquid fuels by using energy from electricity and chemical molecules like hydrogen (Hollinshead *et al.*, 2014).

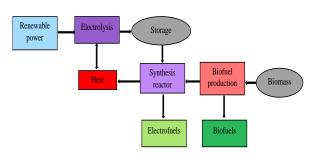


Figure 3. Electrofuel production process. Integrated from Isaacs *et al.* (2021). Illustrated by the authors.

4. Advantages of Biofuel

4.1. Renewable energy source

This is due to the fact that it is composed of organic materials including algae, crops, and plant waste. Unlike fossil fuels, which are scarce and will eventually run out, biofuels are abundant. (Gebremariam and Marchetti, 2018).

4.2. Decreased greenhouse gas emissions

In general, biofuels emit less carbon dioxide (CO_2) than fossil fuels do. This is so because the carbon dioxide those plants take during growth balances out the carbon dioxide that is emitted when biofuels are consumed. Consequently, the total amount of greenhouse gas emissions linked to climate change is decreased by biofuels (Abdulkareem-Alsultan *et al.*, 2020).

4.3. Energy security and independence

A lot of nations rely mostly on imported fossil fuels. Nations can enhance their energy security and independence by lowering their dependency on imported fossil fuels by cultivating biofuels on their own soil (Bento, 2009).

4.4. Employment creation

The cultivation, refining, and marketing of biofuels generate employment in a number of industries, including manufacturing, transportation, and agriculture. This has the potential to lower unemployment rates and boost economic growth (Datta, 2022).

4.5. Environmental benefits

Oil spills and air pollution are two issues surrounding fossil fuel extraction that biofuels may be able to reduce. Since producing biofuel frequently entails growing energy crops on degraded or abandoned land, it can also encourage efforts at land rehabilitation and reforestation (Zhang, 2011).

4.6. Technological advancement

The development of biofuel technology encourages study and innovation within the realm of sustainable

energy. This may result in breakthroughs and developments in other renewable energy fields, like wind and solar energy (Bauer, 2017).

4.7. Profits for farmers

Growing energy crops and selling them to companies that make biofuel can help farmers make money. This can offer another source of money and diversify their sources of income (Pahl, 2008).

4.8. Infrastructure compatibility

Without requiring significant changes, biofuels can be combined with conventional fuels and utilized in already-built systems. Since the infrastructure and transportation systems now in place may be used, the switch from fossil fuels to biofuels is made easier (Bhaskar *et al.*, 2011).

4.9. Development of rural areas

The production of biofuels can give these areas new economic prospects. In rural locations, investing in infrastructure and biofuel facilities can boost employment and the local economy (Gheewala *et al.*, 2018).

5. Limitations of Biofuels

5.1. Competition from land use

Creating biofuels needs an enormous amount of land, that might put food crops, forests, and natural ecosystems in conflict. In areas where land resources are already few, this may exacerbate deforestation, biodiversity loss, and food shortages (Koh and Ghazoul, 2008).

5.2. Increased water usage

The development of numerous biofuel crops, such corn and sugarcane, necessitates substantial water usage. This could put a burden on water supplies, particularly in places where there is currently a drought or limited water availability (Datta, 2022).

5.3. Energy intensive production

Steps that need a lot of energy are commonly included in the manufacture of biofuels, including conversion, processing, and cultivation. Concerns over overall energy efficiency arise because biofuels typically provide a lower total energy gain than their production energy. (Torkashvand *et al.*, 2022).

5.4. Adverse environmental effects

Although biofuels can lower greenhouse gas emissions, there may be additional environmental problems associated with their production. Clearing land for biofuel crops, for instance, may cause ecosystems to be disrupted and stored carbon to be released. Furthermore, water contamination and biodiversity loss might result from the fertilizer and pesticide used in the generating biofuels (Bessou *et al.*, 2011).

5.5. Limited availability of feedstocks

If the appetite for biofuels keeps rising, there won't be as much supply of suitable feedstocks available for the manufacture of biofuels. This may result in more competition for available resources and possibly higher feedstock and food crop costs (Dubey *et al.*, 2023).

5.6. Technical difficulties

Producing biofuel frequently calls for sophisticated technologies and processing techniques. Enhancing the productivity and scalability of biofuel manufacturing, which may be a difficult and drawnout procedure, requires research and development (Ambaye *et al.*, 2021).

5.7. Socioeconomic effects

Communities in the area and indigenous individuals may be affected by alterations in land ownership and usage patterns caused by the emphasis on producing biofuels. Concerns over the loss of small farmers and the consolidation of power in the hands of big businesses might also exist (Aha, and Ayitey, 2017).

5.8. Food security issues

Using food crops to produce biofuels may give rise to food security issues, especially in areas where access to food is already problematic. It is possible that utilizing crops for fuel rather than food may raise food costs and worsen poverty and hunger (Renzaho *et al.*, 2017).

5.9. Complex supply chains

The manufacturing, distribution, and transportation of biofuels entail intricate networks that can be prone to inefficiencies and logistical difficulties. The implementation of biofuels may become less financially viable as a result (Awais *et al.*, 2021).

5.10. Uncertain environmental advantages

Depending on the particular feedstock, production techniques, and total life cycle analysis, biofuels may or may not have different environmental benefits. Some biofuels may not have a substantially less negative environmental impact than fossil fuels, according to some research, especially when indirect emissions and changes in land use are taken into account (Bessou *et al.*, 2011).

6. Current Situation in Developing Countries

Biofuel technologies are experiencing significant growth in developing countries, driven by government policies and investments. Countries like Brazil, Argentina and Indonesia have implemented biofuel blending requirements, driving demand for advanced biofuels like ethanol and biodiesel produced from sustainable feedstocks, reducing greenhouse gas emissions (Bastos *et al.*, 2021).

In Africa, biofuel technology and usage are advancing, albeit unevenly. South Africa leads the continent in biofuel production, accounting for 65% of Africa's total output, while Nigeria, Egypt, Kenya, and others are notable producers (Leela *et al.*, 2024). Although challenges persist, including the food vs. fuel debate, sustainability concerns, and infrastructure limitations. The African Union's Bioenergy Policy Framework promotes sustainable development. Emerging trends include innovative feedstocks, advanced conversion technologies, and regional cooperation (Dahunsi *et al.*, 2020). Biofuel demand is growing, driven by transport sector needs (Miftah and Mutta, 2024).

Nigeria's biofuel industry expands, driven by government policies and growing energy demands (Ndukwu *et al.*, 2021). Biofuels account for 1% of the energy mix, with ethanol from cassava, sugarcane, and maize, and biodiesel from jatropha, palm oil, and soybeans (Munonye *et al.*, 2023). Despite challenges, opportunities lie in agricultural waste utilization and rural development. The Nigerian National Petroleum Company (NNPC) Limited and private investors target 20% biofuel blending by 2030 (Aderinto, 2023).

Despite obstacles in scalability, cost and sustainability, biofuel technologies offer opportunities for developing countries. Utilizing agricultural waste, enhancing energy security and creating jobs are key benefits (Das and Gundimeda, 2022). Emerging trends include algae-based biofuels and carbon capture. Effective policies, infrastructure investments and capacity building will propel biofuel technologies, increasing energy emissions fosterina access. reducing and sustainable development (Oloyede et al., 2024).

7. Conclusion

Biofuels provide a cost-effective and environmentally friendly energy source. They are a long-term energy source because they are renewable resources that can be produced continually. Their effectiveness in lowering greenhouse gas emissions stems from their carbon-neutral or even carbon-negative nature. Additionally, biofuels can promote energy independence and offer chances for waste management. Although there are obstacles to overcome, with careful planning and sustainable methods, biofuels can be used to meet our energy needs while reducing their negative effects on food production and fostering a sustainable future.
